PLEASE READ AND SIGN THE FOLLOWING AGREEMENT: Exhibitor releases and holds harmless the Village of Canal Winchester, the Canal Winchester Labor Day Committee and the directors of the Canal Winchester Labor Day Committee from any and all responsibility, personal liability (injury), loss or damages, theft or fire that may arise or occur to the exhibitor, his employees, goods or property, or to the public from any condition whatsoever that may arise while the exhibitor is occupying the premises. All entries are subject to the approval of the directors. The directors of the festival reserve the right to remove exhibitor or exhibit if this agreement or rules of the festival are breached. Misrepresentation of the merchandise described and displayed will result in cancellation of this agreement with all monies paid forfeited. If, for some reason, beyond the control of the Canal Winchester Labor Day Committee, it becomes impossible to hold the festival, all sums tendered by exhibitor shall be refunded. Exhibitor is responsible for all taxes in connection with sales made. The exhibitor agrees to abide by all festival rules. This agreement is entered into in accordance with the laws of the State of Ohio.
